TOURNAMENT RULES

1. This is a singles tournament open to all male and female bowlers who sanctioned in a Greater Calumet Area USBC league, 50 years of age and over. The tournament will feature four divisions based on average. Bowler must present current years USBC membership card. No membership fees will be collected at the tournament site.
2. Entrants must have reached their 50th birthday on or before January 17, 2021. Age for tournament classification will be as of January 17, 2021. **Entrants must have their birthdate on entry form.**
3. All games will be bowled on one pair of lanes. Multiple participation is allowed as space permits.
4. All sanctioned bowlers that are members of GCA USBC. Use last years (season 2019-2020) highest USBC average. No last year's average or 21 games at the time of bowling, bowler will bowl in Class A.

Averages by class are divided as follows:

Class A: Those with average of 210 or more.

Class B: Those with average of 190-209.

Class C: Those with average of 170-189.

Class D: Those with average of 169 or less.

All participants will be governed by average adjustment requirements. (See USBC Rule 319C (10-pin rule), D and E.)

5. Scores will be based on total pins with handicap for Class A, B, C and D. Handicap is 90 percent of 230 in Class A, 90 percent of 210 in Class B, 90 percent of 190 for those in Class C and 90 percent of 170 in Class D.

6. No previous prize winnings need be reported.

7. Failure to use correct average shall disqualify score and forfeit entry fees and prize winnings if submitted average is lower than the correct average. Prize winnings shall be based on the submitted average if it is higher than the correct average. Correction in average may be made in accordance with rule 319-A(4).

7a. If a bowlers rerated average is higher than their standard average, the rerated average will be used for tournament.

8. Prize money returned 100 percent.

9. In case of a tie for first place, bowlers who tie will share the combined first and second place prizes and be declared co-champions of that particular class. Prizes will be paid on a minimum 1:6 ratio.

10. Winners in all four divisions will receive one ticket to the Annual Greater Calumet Area USBC Hall of Fame and Awards Banquet where they will be honored.

11. All other USBC rules will apply.

12. USBC Rule 319-E (Average Adjustment) will apply to all participants.

13. All entries must be paid before bowling begins. Guaranteed entries require \$5 per person non-refundable deposit.

14. No practice games will be allowed on tournament lanes before tournament bowling begins.

15. Decisions of the Tournament Director are final.
